AUDIT FINDINGS

Narrative:

The audit of Burleigh Morton Detention Center in Bismarck, North Dakota was conducted on October 25 and 26, 2019 by Candy Snyder, a Department of Justice Certified PREA auditor and assisted by Mark Snyder, an auditing assistant.

The auditor was in contact with the PREA Compliance Manager, Sgt. Middlestead, prior to the on-site portion of the audit. Sgt. Middlestead assumed duties a couple of months prior to the audit. Prior to the auditor's arrival the PREA Compliance Manager provided multiple documents both via email and through the PREA Online Audit System (OAS).

An entrance meeting was held with PREA Coordinator, Major Steve Hall; Captain Lisa Wicks, and the PREA Compliance Manager, Sergeant Allyson Middlestead.

Following the entrance meeting Sgt. Middlestead accompanied the audit team on the facility tour. The auditor then began interviewing specialized staff. Private accommodations were made for the auditor to conduct interviews. The facility provided a listing of all inmates and the auditor randomly selected 26 inmates ensuring a representation from all types of housing areas were selected. Some inmates were selected for supplemental questions based on screenings the auditor reviewed. The auditor used the contracted interpreter service to interview two non-English speaking inmates. The auditor was provided a shift roster and selected staff to interview continuing into the evening to include staff who came in for the overnight shift at 7PM. The auditor was not limited in any way from speaking with staff or inmates or inspecting any area of the facility. All staff were extremely polite and accommodating throughout the audit.

An exit briefing was held with the PREA Compliance Manager. The auditor provided a preliminary finding of each standard with the caveat that this was subject to change as the auditor continued to review documents, may have questions to be answered and prepares the interim report.

AUDIT FINDINGS

Facility Characteristics:

The auditor's description of the audited facility should include details about the facility type, demographics and size of the inmate or resident population, numbers and type of staff positions, configuration and layout of the facility, numbers of housing units, description of housing units including any special housing units, a description of programs and services, including food service and recreation. Burleigh County joined with Morton County to build a new detention facility at a new location in Burleigh County. The new facility opened in June 2017. The new Burleigh Morton County Detention Center (BMDC) is constructed with the housing units on either end of the primarily single-level structure. In the center of the building on the east side are the administrative offices, master control, staff offices, staff break room, male and female locker rooms, kitchen, receiving and loading dock, and laundry services. On the west side are the booking area to include a vehicle sally port, pre-booking, search area, property storage and medical offices.

There are currently three housing pods in use. Pods 200 and 300 have six housing units and pod 700 has twelve housing units spoking around a central pod control for direct lines of sight by the pod control room officer. Each pod has a programming room that is used for any program functions such as chaplain services and group meetings. There is one shared recreation area shared between every two housing pods. For pods 700 and 800 a maximum of 16 inmates attend recreation at one time. For all other pods each housing unit attends recreation together.

On the south end of the building are housing pods 200 and 300. Each pod has a capacity of 112 inmates. Units 210, 220, 230 and 260 are for male maximum security inmates. Units 240 and 250 are for male pre-classification inmates. Unit 270 is for female maximum security inmates. Unit 280 is for female pre-classification inmates. Housing pods 310, 320, 330, 340, 350 and 360 are for male inmates. Housing pods 370 and 380 are for female inmates. Housing pod 400 is a pad designed for future construction if needed for expansion. Housing pod 500 is a mental health/special needs housing pod that is currently not in use. On the north end of the building are housing pods 700 and 800. Pod 700 is for minimum classification inmates with units 715, 720 725, and 730 for female inmates and the remaining 700 series units for male inmates. Pod 800 is currently not used.

Each housing unit has a phone that is specifically used for contacting the pod control officers. In addition, each housing unit has a commissary kiosk. The inmate must watch the PREA video on the kiosk before they can make their first order.

AUDIT FINDINGS

The PREA Coordinator and the PREA Compliance Manager have continued to ensure all PREA compliance measures as well as policies and procedures comply with all standards. There were a few standards that the auditor felt needed some minor adjustments and one corrective action. These minor adjustments and the one corrective action were completed prior to the interim report being issued so a final report was provided within 45 days following the on-site portion of the audit.

CORRECTIVE ACTIONS

Standard 115.41 Screening for risk of victimization and abusiveness

CORRECTIVE ACTION: The auditor required the facility directly ask the screening question regarding how an inmate identifies not just recording staff's perception. The BMDC provided a screening form with the required modification.

	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	<p>The BMDC has a thorough PREA policy that is modeled from PREA Standards. The policy states in writing that the BMDC has a zero tolerance policy of sexually abusive behavior and sexual harassment. The PREA Coordinator is training the PREA Compliance Manager to assume the Coordinator role for succession planning. The PREA Coordinator and the PREA Compliance Manager are set within the organizational structure to ensure the BMDC staff work with them to maintain compliance by following necessary procedures they set up. Policies and procedures are often reviewed and revised based on committee assignments that affords buy-in by all staff. The auditor recommended a minor change in the wording on the zero policy statement by changing the sentence "The Burleigh Morton Detention Center will have written policies and procedures mandating zero tolerance towards all forms sexual abuse and sexual assault" to "This Burleigh Morton Detention Center policy mandates zero tolerance towards all forms of sexual abuse and sexual harassment".</p>

	The BMDC does not contract with other facilities for confinement of BMDC inmates.

115.13	Supervision and monitoring
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	<p>The auditor interviewed the Sheriff, the PREA Coordinator, the PREA Compliance Manager, staff and inmates. Staff levels are reviewed annually during the budget planning process to determine appropriate adjustments to the staffing plan, monitoring technology or the allocation of facility resources to ensure agreement with the staffing levels. The staffing plan lists each post and the hours of each shift needed to cover that post. The auditor reviewed the schedules, logbooks, and viewed the camera coverage within the control rooms. Based on these interviews and observations, the BMDC has developed, documented, and made its best efforts to comply on a regular basis with staffing levels that provide for adequate levels of staffing, and uses video monitoring, and other technology to protect inmates against sexual abuse. Staffing levels are also reviewed annually by the North Dakota Department of Corrections and Rehabilitation (DOCR) and found to be adequate. They have no documented instances of following below their required staffing levels. They will document and justify all deviations from the plan if they fall below the normal staffing level in their exigent circumstance log.</p> <p>The inmate visual search at booking is completed by a single officer within the search room of the booking area. The auditor recommended that either another staff or a camera is placed so that the staff conducting the visual search is either on camera or viewed by another staff member. Inmates in isolated one-on-one situations with staff, and especially when they are in a state of undress as they are during the visual search, are at risk. For the protection of both the inmate, and the staff against false allegations, it is preferred that the searcher be in view by another staff member or a camera.</p> <p>The facility had documented unannounced rounds conducted by mid-level staff and upper level staff to include the Major, the Captain, Sergeants and Corporals. The unannounced rounds are at varying times and includes nights and weekends.</p>

115.14	Youthful inmates
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The BMDC does not house youthful offenders.

115.15	Limits to cross-gender viewing and searches
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	<p>The facility does not conduct cross-gender strip searches or cross-gender visual body cavity searches (meaning a search of the anal or genital opening) except in exigent circumstances or when performed by medical practitioners. In the event a cross gender search is done in an emergency situation, the facility will document all cross-gender strip searches and cross-gender visual body cavity searches in their exigent circumstance log.</p> <p>The facility has policies and procedures that enable inmates to shower, perform bodily functions, and change clothing without staff of the opposite gender viewing except in exigent circumstances or when such viewing is incidental to routine cell checks. Such policies and procedures require staff of the opposite gender to announce their presence when entering an inmate housing unit. Inmates confirmed during interviews that the announcement was made as a matter of routine and staff announced the auditor's presence as she entered male housing areas. The facility does not search or physically examine a transgender or intersex inmate for the sole purpose of determining the inmate's genital status. If the inmate's genital status is unknown, it is determined during conversations with the inmate, by reviewing medical records, or, if necessary, by learning that information as part of a broader medical examination conducted in private by a medical practitioner.</p> <p>The schedule showed adequate female staff scheduled and inmates stated there are always female staff available to conduct a search of a female inmate.</p> <p>The facility uses a rounds tracker system to track correctional officer rounds through each housing unit. In some housing units the red button to be scanned is located near the shower. The auditor recommends that these be relocated away from the shower so that an officer of the opposing gender conducting rounds does not have to go near the shower in order to scan the rounds tracker button. The administrative staff stated that this item had already been addressed and they have plans to relocate a few of the red buttons that are located near showers.</p> <p>The BMDC trains security staff in how to conduct cross-gender pat- down searches, and searches of transgender and intersex inmates, in a professional and respectful manner, and in the least intrusive manner possible, consistent with security needs. During interviews with staff they were able to articulate the differences in the search and some physically demonstrated the search using the back of the hand.</p>

115.16	Inmates with disabilities and inmates who are limited English proficient
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	<p>The BMDC takes steps to ensure inmates with disabilities including inmates who are deaf or hard of hearing, those who are blind or have low vision, or those who have intellectual, psychiatric, or speech disabilities have an equal opportunity to participate in or benefit from all aspects of the facility's efforts to prevent, detect, and respond to sexual abuse and sexual harassment. The auditor interviewed two non-English speaking inmates using the BMDC's contracted interpretive service. The auditor also interviewed an inmate with intellectual disability. The inmates stated they understood the zero tolerance policy and how to report an incident.</p> <p>Inmates are first provided basic information verbally during booking. Then during orientation they are given a PREA handout titled "Sexual Assault Awareness". This handout is also available in Spanish. The staff conducting the orientation explains the information verbally to those who may need assistance. There is also a poster posted in every housing unit. The poster is also in Spanish. The BMDC does not rely on inmate interpreters, inmate readers, or other types of inmate assistants except in limited circumstances where an extended delay in obtaining an effective interpreter could compromise the inmate's safety. The video has Spanish subtitles and inmates stated the staff are good at explaining things if you don't understand.</p>

115.17	Hiring and promotion decisions
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	<p>The auditor interviewed the Human Resource Manager responsible for hiring and reviewed personnel files for necessary documentation. The Human Resource Manager is extremely organized and had all necessary documentation for new hires as required by the standard. The facility has performed background checks at the time of employment of new hires and every five years thereafter. The BMDC includes the required three questions as well as a continuing duty to report during the employment process. The HRM will ensure that that this form is completed annually during the annual reviews.</p>

115.18	Upgrades to facilities and technologies
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The BMDC is a newly constructed facility which opened in June 2017. The building was constructed with clear lines of site into each housing unit for the pod control room. The facility has new cameras, new DVRS, intercom systems and a rounds tracking system.

115.21	Evidence protocol and forensic medical examinations
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The BMDC offers all victims of sexual assault access to forensic medical examinations through Sanford Health without financial cost. Such examinations are performed by Sexual Assault Nurse Examiners (SANEs). The facility also makes available to the victim a victim advocate from the Abused Adult Resource Center (AARC). AARC has a MOU with the North Dakota Department of Corrections and Rehabilitation. The auditor verified with the Director of AARC that this MOU encompasses services provided to the BMDC. If requested by the victim, a victim advocate accompanies and supports the victim through the forensic medical examination and investigatory interviews and provides emotional support, crisis intervention, information, and referrals. The investigator from Burleigh County Sheriff's Office stated he has received training in sexual abuse investigations and evidence collection and has worked with the SANE nurse in evidence collection on previous investigations outside of the detention center. The investigator immediately reaches out to the state's attorney once there is evidence of sexual assault.

115.22	Policies to ensure referrals of allegations for investigations
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The protocol following a report of a sexual assault is that the BMDC staff will call the investigator from the Sheriff's Office. The sheriff's office investigator conducts prompt and thorough investigations of all allegations of misconduct. He has law enforcement authority to conduct investigations concerning any allegation of criminal action. An alleged incident of sexual harassment, or incident otherwise deemed to be a PREA violation that does not rise to the level of sexual abuse, is referred to an administrative PREA investigator who has received PREA incident investigation training. There is written investigative policy and it is published on the BMDC website.

115.31	Employee training
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The BMDC provides PREA training to all staff. The auditor reviewed training documentation and curriculum. The facility has very good records that include a roster with acknowledgment sheet that the employee or contractor signs stating they understand the training. Staff were well versed in required PREA training when interviewed.

115.32	Volunteer and contractor training
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The BMDC provides PREA training to volunteers and contractors at a level that is dependent upon their level of contact with the inmates. Training was verified through the interview process with volunteers and through review of training records. Contractors and volunteers were instructed how to report if an inmate reported sexual assault or harassment. There typically are no unescorted contractors allowed in inmate areas. The food service contractors work in the kitchen and have absolutely no contact with inmates. Inmates are not allowed into the kitchen. There is a locked door between the kitchen and the dish room where the inmates work. The corrections staff take the food to the inmate housing areas.

115.33	Inmate education
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The BMDC provides inmates information immediately upon booking into the facility. This initial information is on the zero tolerance policy regarding sexual abuse and sexual harassment and how to report incidents or suspicions of sexual abuse or sexual harassment. This was evident through the interviews with inmates. They stated that they received some basic information immediately (during booking) and then later received more comprehensive information to include a video. They also referenced that the information is always available through the posters on the unit walls and in the inmate handbook on the kiosk.

115.34	Specialized training: Investigations
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	<p>The BMDC has a trained facility investigator to conduct administrative investigations. The administrative investigator has completed the PREA: Investigating Sexual Abuse in a Confinement Setting course through the National Institute of Corrections. All criminal allegations are turned over to the Burleigh County Sheriff's Department for investigation. The investigator through the sheriff's department has worked over 21 years as a law enforcement officer and has extensive experience in sexual assault investigations. He works with others to form a coordinated response effort to include the SANE nurse and the advocates from the Adult Abuse Resource Center. He has completed basic PREA training and the PREA: Investigating Sexual Abuse in a Confinement Setting course through the National Institute of Corrections and an investigations course through the Moss group.</p>

115.35	Specialized training: Medical and mental health care
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	<p>The nursing staff and mental health specialist have completed basic PREA training and the specialized training through the National Institute of Corrections "PREA Medical Health Care for Sexual Assault Victims in Confinement". Through interviews it is apparent they are knowledgeable in how to detect and assess signs of sexual abuse and sexual harassment; how to preserve physical evidence of sexual abuse; how to respond effectively and professionally to victims of sexual abuse and sexual harassment; and how and to whom to report allegations or suspicions of sexual abuse and sexual harassment. No forensic examinations are conducted on site. All inmates who would report a sexual assault are transported to the local hospital with SANE services.</p>

115.41	Screening for risk of victimization and abusiveness
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	<p>The BMDC screening process is conducted by the booking officers through a form that is on the booking computer. The booking officer conducts the screening for all incoming inmates. If an inmate, through the screening process, is determined to be susceptible to victimization or perpetration of sexual abuse, this is shared with staff only to the extent necessary to provide for the well-being of the inmate.</p> <p>CORRECTIVE ACTION: The auditor required the facility directly ask the screening question regarding how an inmate identifies not just recording staff's perception. The BMDC provided a screening form with the required modification.</p>

115.42	Use of screening information
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	<p>The BMDC makes decisions based on all information obtained from the screening to make housing, bed, program, and work assignments for inmates with the goal of keeping all inmates safe and free from sexual abuse. Inmates are placed in housing on a case-by-case basis. The BMDC ensures placement is appropriate for the inmate's health and safety, and that the placement also alleviates management or security problems. The facility staff will take into account the concerns of a transgendered or intersex inmate's own views with respect to his or her own safety. Those views are given serious consideration, and this was demonstrated through the interviews of staff. All inmates shower separately at the facility. The facility does not place lesbian, gay, bisexual, transgender, or intersex inmates in particular housing, bed or other assignments solely on the basis of such identification or status, nor does the facility consider lesbian, gay, bisexual, transgender, or intersex identification or status as an indicator of likelihood of being sexually abusive.</p>

115.43	Protective Custody
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The BMDC considers the least upsetting placement for the alleged victim. Staff interviews confirmed that inmates at high risk for sexual victimization are not placed into protective custody unless the inmate cannot be protected by any other means. A review of status for protective custody would be completed at a minimum of every 30 days. They have not placed any alleged inmate victims of sexual abuse or sexual harassment in involuntary segregated housing.

115.51	Inmate reporting
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The BMDC provides multiple internal avenues for inmates to report sexual abuse, sexual harassment and retaliation. They can tell any staff member, write a message on the kiosk, write an inmate grievance form, report to a third party, or place a call free of charge to the Abused Adult Resource Center using the unit phone. The auditor verified by dialing the number posted from an inmate housing unit and spoke with a staff member at the Abused Adult Resource Center about her actions if she received a phone call from the detention facility. Inmate interviews confirmed that inmates are aware of their options.

115.52	Exhaustion of administrative remedies
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	Inmates may submit a grievance alleging sexual abuse or harassment without submitting it to a staff member that is subject of the allegation. The inmate does not have to complete any other prior steps in order to submit a grievance for an allegation of sexual abuse. There is also no time limit on when an inmate can submit a grievance regarding an allegation of sexual abuse. Staff and inmate interviews confirmed their knowledge of how the grievance process can be used to report sexual abuse and sexual harassment.

115.53	Inmate access to outside confidential support services
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The BMDC uses the services of the Abused Adult Resource Center. All inmates see medical within the first 14 days at the detention center for further screening. In addition, both staff and inmates verified that the medical staff could set up a visit with mental health staff at West Central Human Service Center. The BMDC provides inmates with reasonable and confidential access to their attorney. In addition, inmates interviewed reported that they had contact with their families regularly.

115.54	Third-party reporting
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The BMDC website provides information on how an individual can make a third-party report and contact information is available. Third parties are able to report sexual abuse and sexual harassment to any facility staff member. The BMDC has not received any third-party reports. Interviews with staff and inmates confirm that staff and inmates are aware that third party reporting options are available.

115.61	Staff and agency reporting duties
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The BMDC PREA policy requires all staff to immediately report any knowledge, suspicion, or information regarding an incident of sexual abuse or harassment and for staff not to reveal any information related to a sexual abuse report to anyone other than the extent necessary. Staff interviewed understood and spoke specifically about this procedure. Inmate interviews supported the fact that inmates are also aware of the reporting and confidentiality requirements of sexual abuse and sexual harassment.

115.62	Agency protection duties
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The BMDC PREA policy requires staff to take immediate action to protect any inmate they learn is subject to substantial risk of imminent sexual abuse. All staff interviewed are aware of this procedure. Review of files verified that immediate action is taken.

115.63	Reporting to other confinement facilities
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The auditor confirmed through interviews with the Sheriff and the Major that upon receiving an allegation that an inmate was sexually abused while confined at another facility, the notify the head of the facility or appropriate office of the agency where the alleged abuse occurred. An investigation will be initiated immediately. This notification is made immediately, but at least within 72 hours and documented. There was one reported incident by an inmate that allegedly occurred at another facility.

Interviews with random staff confirmed knowledge of these procedures. All staff understood that an inmate who alleges sexual abuse is taken to the hospital and how the advocate, investigator and SANE nurse work together to support the victim.

The facility accepted this advice and assigned the responsibility specifically to the PREA Compliance Manager. The PREA Compliance Manager may task a specific staff to follow-up with an inmate and then email the follow-up information so that it can be incorporated into a retaliation log that is maintained in the Administrative office. The monitor will record each time they check in with those who have reported sexual assault or sexual harassment and continue to monitor for retaliation up to a 90-day period or for as long as needed.

All written reports will be retained for at least seven (7) years from inmate(s) discharge. Investigations will not be terminated due to the departure of an alleged abuser or victim. The facility will cooperate with outside investigators and will remain informed of the investigation progress.
