Bismarck's Growth Phasing Plan and the Extraterritorial Area (ETA)

Bismarck's Growth Phasing Plan, adopted as a component of the City's comprehensive plan, shows areas outside of city limits expected to be annexed and urbanized in the future. This plan is revised each year by the Bismarck Planning and Zoning Commission to account for changing development conditions, and this year's amendment process may be a timely opportunity for reconsidering the negotiated boundaries of the extraterritorial area (ETA) between the City of Bismarck and Burleigh County.

Proposed Growth Phasing Plan

There are two areas of the Growth Phasing Plan relevant to the ETA discussion:

- **Urban Service Area**: an area suitable to support urban growth of Bismarck outside of city limits for a projected 25 years.
- **Urban Reserve**: an area suitable to support urban growth of Bismarck beyond the urban service area for a projected 50 years.

The following changes will be proposed for this year:

 Revise the outer boundaries of the Urban Reserve areas so that no lot or parcel would be split by the boundary. This would make the line suitable as a negotiated ETA boundary.



- Create a new Airport Buffer around the departing runway of the Bismarck airport. This
 area would not be expected to urbanize within the time horizon of the plan but should be
 retained in the ETA for airport operational purposes.
- Minor changes to the boundaries of the Urban Reserve and Urban Service Area boundary to reflect updated growth projections.

City staff propose to set the boundaries of the ETA to only include the Urban Service Area, Urban Reserve, and Airport Buffer and remove all other areas outside of City Limits from the ETA. By North Dakota state law, all matters of zoning, including establishing the boundaries of the City's extraterritorial authority, must be done in conformance with the Comprehensive Plan. We believe these changes the plan and negotiated agreement would comply.
