

COMMENCING AT THE NORTHWEST CORNER OF SAID SECTION 12; THENCE S 00°42'42" W ALONG THE WEST LINE OF SAID SECTION 12, 361.47 FEET TO THE POINT OF BEGINNING; THENCE FROM SAID POINT OF BEGINNING N 89°43'07" E, 528.00 FEET; THENCE S 00°42'42" W, 495.00 FEET; THENCE N 89°43'07" E, 1334.00 FEET; THENCE S 00°42'42" W, 468.00 FEET TO THE SOUTH LINE OF THE NORTH HALF OF SAID NORTHWEST QUARTER; THENCE ALONG SAID SOUTH LINE S 89°43'07" W, 1862.00 FEET TO THE WEST LINE OF SECTION 12; THENCE ALONG SAID WEST LINE N 00°42'42" E, 963.00 FEET TO THE SAID POINT OF BEGINNING.
