CALL TO ORDER

Mayor Schmitz called the meeting to order at 4:00 PM.

ROLL CALL

Committee members present were City Administrator Jason Tomanek, City of Bismarck Mayor Mike Schmitz, and Burleigh County Commissioner Wayne Munson. Burleigh County Auditor Mark Splonskowski was absent.

Roll Call

Committee members present Burleigh County Auditor Mark Splonskowski, Burleigh County Commissioner Steve Bakken, and City Administrator Jason Tomanek. City of Bismarck Mayor Mike Schmitz attended the meeting via Teams.

Agenda

1. Consider approval of minutes

Mayor Schmitz motioned to approve the April 2, 2024, meeting minutes, and Auditor Splonskowski seconded. Upon a roll call vote, all voted aye.

2. Bismarck Burleigh Public Health Update

Bismarck Burleigh Public Health Director Renae Moch presented information regarding the draft bylaws for a Joint Board of Health. The group discussed the need for a board member application that reflects professional medical experience and agreed to collaborate to create an application.

3. Dakota Media Access Discussion

Dakota Media Access Executive Director Mary Van Sickle addressed the Committee regarding the growing need for funding and increased requests for meeting coverage for Dakota Media Access. Primary funding for Dakota Media Access is provided by the City of Bismarck and the City of Mandan. The funding source is composed of the franchise fees for cable subscribers through Midco, which is collected by the Cities and is on a downward trend as fewer homeowners are paying for cable subscriptions. Ms. Van Sickle is open to discussing options for strategies to share the ongoing operating expenses.

4. Provident Building Update

Commissioner Bakken reported that Burleigh County will remain a tenant in the City/County Building through the end of 2025.

5. Other Business

Commissioner Bakken raised the topic of storm water-related concerns in rural subdivisions. Commissioner Bakken noted that the topic was discussed at the Burleigh County Commission meeting the night prior. It was agreed that the topic will be added to the next Bismarck Burleigh Commissions Committee on June 4, 2024.

4/2/2024 - Minutes

Call to Order

Commissioner Bakken called the meeting to order at 4:00 PM.

Roll Call

Committee members present were Mayor Mike Schmitz, Burleigh County Commissioner Steve Bakken, City Administrator Jason Tomanek, and Burleigh County Auditor Mark Splonskowski.

1. Consider approval of minutes

Mayor Schmitz motioned to approve the March 5, 2024, meeting minutes, and Auditor Splonskowski seconded. Upon a roll call vote, all voted aye. M/C.

2. Burleigh County Home Rule Charter

A. 1/2-Cent Sales Tax Initiative

Burleigh County Commissioner Munson shared an informational video regarding the 1/2 cent Sales Tax initiative. Commissioner Munson informed the committee that the current 1/2 cent sales tax will have generated enough revenue to cover the initial debt caused by the construction of the Burleigh Morton Detention Center. Commissioner Munson indicated a 1 cent Burleigh County collection is estimated to generate \$22 million annually. The sales tax revenue will be used to support the Detention Center, the Sherriff's Department, the States Attorneys Office, and a property tax reduction of approximately \$150 per \$100,000 valuation.

3. Bismarck Burleigh Public Health Update

Commissioner Munson and Renae Moch, Bismarck Burleigh Public Health Director, provided information regarding the core functions of Public Health units, as mandated by ND Century Code Chapter 23-25. Commissioner Munson has worked with Director Moch to create a document to explain what services are required by ND Century Code, the services that BBPH provides, and also how the services are funded. The largest portion of services which include communicable disease control is primarily funded by grants.

Commissioners Cleary and Munson spoke in favor of creating a Public Health Advisory

Board that will function similar to the Planning and Zoning Commission which consists of both City, County, and public board members. This board would be in an advisory position and would report to each respective Board of Health.

Commissioner Bakken asked Director Moch to provide the draft bylaws for the Committee to review as well as a list of services that BBPH currently provides at the May meeting.

4. Provident Building Update

Commissioner Bakken informed the Committee that the department directors have met with the architect for the Provident Building Update and will have a project timeline at the May meeting.

5. Other Business

2. Discuss Extraterritorial Area (ETA)

Gary Stockert, Bismarck Emergency Manager, and Brady Blaskowski, Bismarck Building Official, provided an update on the Community Rating System (CRS) Certification. This is a program that provides reductions to flood insurance rates.

Commissioner Bakken questioned how the CRS impacts Burleigh County residents. Mr. Stockert explained that Burleigh County residents within the Extraterritorial Area (ETA) are directly and positively impacted by the program and that Burleigh County would need to apply to the program to make the benefits available to Burleigh County residents outside the ETA.

3. Provident Building Update

Commissioner Bakken provided information on the status of the Provident Building. Burleigh County has signed a contract with an architecture firm, and the project will be moving forward. Commissioner Bakken noted that it will likely be June 2025 before the County is able to occupy the Provident Building. They will provide an update at the May meeting prior to each organization's budget meetings.

Call to Order

1. Consider approval of minutes

2. Discuss Extraterritorial Area (ETA)

Ben Ehreth, Community Development Director, presented information regarding ETA agreements including new agreements with Apple Creek Township and Missouri Township. Director Ehreth also addressed questions regarding the differences between the City and County's permit regulations and noted that flood plain regulations are a significant difference between City and County as the county adheres to the 500-year flood plan and the City does not. Dennis Wetzel who resides at 6111 Apple Creek Drive addressed the Committee with his concerns regarding the ETA.

3. Provident Building Update

Chair Bakken and Commissioner Munson provided information on the status of the Provident Building. The predesign will be completed in 30 days and they expect to complete the bid process within six months. They will provide an update at the next meeting.
