

SUNSHINE ACRES FIRST SUBDIVISION

ALL THAT PART OF THE SOUTHWEST QUARTER (SW1/4) OF SECTION 3, TOWNSHIP 137 NORTH, RANGE 80 WEST OF THE 5TH PRINCIPAL MERIDIAN, BURLEIGH COUNTY, NORTH DAKOTA THAT LIES WITHIN AND IS BOUNDED BY THE FOLLOWING DESCRIBED TRAVERSE:

THE POINT OF BEGINNING IS THE SOUTHWEST CORNER OR SAID SECTION 3. FROM SAID POINT OF BEGINNING, THE TRAVERSE BEARS NORTH 00°-00'-59" EAST, ALONG THE WEST LINE OF SAID SECTION, A DISTANCE OF 1920.26 FEET; THENCE BEARING NORTH 89°-42'-20" EAST A DISTANCE OF 719.46 FEET; THENCE BEARING SOUTH 00°-00'-00" WEST A DISTANCE OF 1921.60 FEET TO THE SOUTH LINE OF SAID SECTION; THENCE BEARING SOUTH 89°-48'-45" WEST A DISTANCE OF 720.00 FEET TO THE POINT OF BEGINNING.
